**Ordinance No. 793**

**(Series 2013)**

**AN ORDINANCE OF THE TOWN OF PAGOSA SPRINGS AMENDING SECTION 16.4.12(2)(A), OF THE TOWN OF PAGOSA SPRINGS MUNICIPAL CODE**

**WHEREAS**, the Town of Pagosa Springs (“Town”) is a home rule municipality duly organized and existing under Article XX of the Colorado Constitution and the Pagosa Springs Home Rule Charter of 2003; and

**WHEREAS**, pursuant to Section 1.4 A) of the Charter, the Town has all power of local self-government and home rule and all power possible for a municipality to have under the Constitution and laws of the State of Colorado; and

**WHEREAS**, pursuant to Article XX, Section 6 of the Colorado Constitution and Section 16.4.13 of the Municipal Code, the Town has the power to amend or repeal the provisions of this Article, including all provisions regarding collection, administration, use and enforcement of the lodgers’ tax, except that the amount of the tax and events subject to the tax as approved by the voters on November 1, 2005 shall not be increased, expanded or broadened without additional voter approval to adopt and amend ; and

**WHEREAS**, the Town Council has, by Ordinance, adopted the Pagosa Springs Municipal Code, Chapter 16 , Article 4 "Lodger’s Tax" and section 12(2)(a) "Town Tourism Committee"; and

**WHEREAS**, the Town Council hereby determines that for the protection of the health, safety and welfare of the Town, it is in the best interest of the Town Tourism Committee of the Town to amend section 16.4.12(2)(a) of the "Members and Terms of Office" regarding seat allocations; and

**NOW, THEREFORE, BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF PAGOSA SPRINGS, COLORADO**, Section 16.4.12(2)(a) reads as follows:

Section (2) Members and Terms of Office.

(a) The Town Tourism Committee members shall be appointed by the Town Council by resolution with representatives as follows:

- Lodging Association 1
- Realtors’ Association 1
- Chamber of Commerce 1
- At-Large 8

**Section 1. Public Inspection.** The full text of this Ordinance, with any amendments, is available for public inspection at the office of the Town Clerk.

**Section 2. Severability.** If any portion of this Ordinance is found to be void or ineffective, it shall be deemed severed from this Ordinance and the remaining provisions shall remain valid and in full force and effect.

**Section 3. Public hearing.** A public hearing on this Ordinance shall be held on the 6<sup>th</sup> day of August, 2013, at 5:00 p.m. at the Pagosa Springs Town Hall, 551 Hot Springs Boulevard, Pagosa Springs, Colorado.

**Section 4. Effective date.** This Ordinance shall become effective and be in force immediately upon final passage at second reading.






**CERTIFICATE OF PUBLICATION**


