**RESOLUTION NO. 2013-24**

**A RESOLUTION OF THE TOWN OF PAGOSA SPRINGS,  
COLORADO, APPOINTING MR. MIKE LEROUX, MS.  
SALLY HIGH AND MR. JEFF GREER TO THE PARKS AND  
RECREATION COMMISSION.**

**WHEREAS**, Town Ordinance No. 655 establishes powers and duties, qualifications, and terms for members of the Parks and Recreation Commission (PRC); and

**WHEREAS**, Section 14.3.2(2)(a) of the Town of Pagosa Springs Municipal Code states that the Park and Recreation Commission shall consist of no fewer than five (5) and no more than nine (9) members, who shall be appointed by the Town Council by resolution; and

**WHEREAS**, the PRC recommends the appointment of Mr. Mike Leroux for a one (1) year term, as a member of the Parks and Recreation Commission; and

**WHEREAS**, the PRC recommends the appointment of Ms. Sally High for a one (1) year term, as a member of the Parks and Recreation Commission; and

**WHEREAS**, the PRC recommends the appointment of Mr. Jeff Greer for a one (1) year term, as an alternate member of the Parks and Recreation Commission; and

**THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF  
PAGOSA SPRINGS,**

**1. Appointment of Parks and Recreation Commission Member.** Mr. Mike Leroux is hereby appointed to serve as a member of the Parks and Recreation Commission for a one (1) year term, commencing in October 2013 and which will conclude in October 2014.

**2. Appointment of Parks and Recreation Commission Member.** Ms. Sally High is hereby appointed to serve as a member of the Parks and Recreation Commission for a one (1) year term, commencing in October 2013 and which will conclude in October 2014.

**3. Appointment of alternate Parks and Recreation Commission Member.** Mr. Jeff Greer is hereby appointed to serve as an alternate member of the Parks and Recreation Commission for a one (1) year term, commencing in October 2013 and which will conclude in October 2014.


**4. Severability.** If any part, section, subsection, sentence, clause or phrase of this Resolution is for any reason held to be invalid, such invalidity shall not affect the validity of the remaining provisions.

5. **Effective Date.** This Resolution shall take effect and be enforced immediately upon its approval by the Town Council.


