Co 1.	onditions: The Town accepts Banner Applications at any time in the current year. Banner Applications for the following years scheduling will be accepted beginning January 2nd. Payment is due at time of application submission.				
2.	Banners promoting events sponsored or affiliated with religious organizations may be allowed. Banners intended to promote or inhibit a specific religion shall not be allowed.				
3.	The Town of Pagosa Springs reserves the right to refuse to hang any banner determined to be unsafe or unsuitable.				
4.	The banner MUST have the proper configuration of grommets to facilitate hanging it. One grommet must be placed at each corner. Grommets must be placed along the bottom and top edges, equally spaced and not more than 24" apart. Vinyl banners shall have two rows of "U" shaped wind holes (6" x 6") cut no more than 24" apart and equally spaced throughout the banner.				
5.	Banners must be delivered to the Community Center (451 Hot Springs Blvd) one (1) week prior to the installation date if not received by this date the banner may not be hung and no refund will be given.				
6.	Banners must be picked up immediately after removal date. If not claimed within ten (10) days, a \$50 storage fee will be assessed. The Town of Pagosa Springs is not responsible for damage or loss of banner.
