Invitation to Bid 2024-PW-07 New Water Truck Town of Pagosa Springs

Responses Due By 4 p.m. on January 15, 2024

The Town of Pagosa Springs is soliciting bids from qualified firms and individuals for a **New Water Truck**.

Any requests for clarification or additional information deemed necessary by any respondent to present a proper bid shall be submitted **in writing** to Brad Lattin, Streets Supervisor, 551 Hot Springs Blvd, PO Box 1859, Pagosa Springs, Colorado, 81147 or <u>blattin@pagosasprings.co.gov</u>, referencing this Invitation to Bid. Written requests for information must be received a minimum of two (2) days prior to the bid submission date. Any request received after the above stated deadline will not be considered. All requests received prior to the above deadline will be responded to in writing by the Town in the form of an addendum addressed to all prospective respondents.

No Bids may be withdrawn within a period of thirty (30) days after the due date of January 15, 2024. The Owner reserves the right to reject all bids and to waive irregularities or informalities in any bid.

I. Scope of Equipment

The Town of Pagosa Springs Public Works Department, Streets Division is requesting bids for a **New Water Truck**. For equipment specification, see Attachment "A", **Specification Verification and Delivery Sheet**. Bid responses must include pricing for all optional equipment requested. See Attachment "B" for **Bid Pricing Sheet**.

II. Instructions to Bidders

A. **Cost Proposal** - Provide a cost proposal in detail per the below fee schedule.

Fee schedule:

- a. State your price per unit to deliver the equipment in accordance with Attachment "A" and Attachment "B".
- b. State any other costs the Town may anticipate relating to the services to be

provided.

- B. Additional Information Include any additional information you feel will assist us in the evaluation of your qualifications. Please state why you and/or your firm should be selected.
- C. **Conflict of Interest** Disclose any potential conflicts of interest in working on behalf of the Town, including any employees, elected officials, or other stakeholders working for the Town.
- D. **Availability/Schedule**-Provide information about your availability including any potential conflicting dates or times.

III. Submission Deadline and Requirements

- A. Submission Deadline: Emailed bids will be received by the Town of Pagosa Springs at Town Hall 551 Hot Springs Boulevard, PO Box 1859, Pagosa Springs, Colorado 81147 until January 15, 2024, at 4:00p.m. local time. Bids received after the submission deadline will not be accepted. Candidates will be notified in writing by email or verbally by phone if selected.
- B. Submittal Requirements: Each bid must be submitted to <u>blattin@pagosasprings.co.gov</u> to be considered. Bids must detail their costs based on conditions listed under the Scope of Equipment and Instructions to Bidders and will include Attachment "A" and Attachment "B". The email's subject line needs to be "New Water Truck".

IV. Selection Process

Bids will be evaluated and scored based on the following criteria and points:

- **Experience and Qualifications**: Demonstrated prior experience with requested services (40 points)
- Pricing Structure: Competitiveness of pricing proposal (60 points)

The bid will be awarded to the firm/individual whose bid will be, on an overall basis, most advantageous to the Town of Pagosa Springs. The Town of Pagosa Springs selection decision is final.

V. Terms and Conditions

This Invitation to Bid does not commit the Town of Pagosa Springs, Colorado to award a contract, to pay any costs incurred in the preparation of bids to the requests, or to procure or contract service or supplies. The Town of Pagosa Springs reserves the right to accept or reject any or all bids received as a result of this request, to negotiate with any qualified source, or to

cancel in part or in its entirety the Invitation to Bid, if it is in the best interest of the Town of Pagosa Springs, Colorado.
