I agree that I will not submit any change order(s) associated with the original scope of work that, in total with all previous applications for change orders, exceed ten (10%) percent of the original bid price as defined within this bid form.

It will be at the discretion of the owner to determine if the change orders are necessary to complete the original work of scope. Additionally, it will be up to the owner in its sole and absolute discretion to determine if change orders which exceed the ten percent (10%) threshold are within or outside of the original scope of work, and if outside of the original scope of work whether they would provide significant benefit to the overall project.
