



TOWN OF PAGOSA SPRINGS LODGING TAX RETURN

WHO MUST FILE A RETURN

If you offer lodging for a purchase price within the Town; or that is managed, contracted or leased by a person engaged in lodging business within the Town.

Remember,

6.9% State Sales Tax is also required to be collected.

WHEN YOU MUST FILE

Returns are filed monthly and are due by the 20th day of the month succeeding the month for which you are filing.

LINE 1 Sales of lodging services – Enter the gross income from such rentals.

LINE 2 Tax – Multiply the amount on line 1 by the Town lodging tax rate of 4.9% (.049). Enter on line 2.

LINE 3 Penalty – Enter 10% (.10) of line 2 if return is not filed timely.

LINE 4 Interest and Penalty Interest – Interest is due if a return is more than one month late. Penalty interest is also due. The interest rate is 1% (.01) per month over due.

LINE 5 TOTAL DUE – Add lines 2, 3 and 4. Pay this amount.
